Note: This completed application and a twenty-five dollar (\$25.00) permit fee must be received by the City of Brenham at least eight (8) days prior to operation. **INCOMPLETE APPLICATIONS WILL NOT BE ACCEPTED.** Application for a permit does not guarantee that a permit will be granted.

Note: Any application and permit fee received by the City of Brenham within seven (7) days of operation will have a twenty-five dollar (\$25.00) late charge added to the permit fee. For a total charge of fifty dollars (\$50.00).

Note: All temporary food establishments (TFEs) shall meet the requirements of the Texas Food Establishment Rules (Temporary Food Establishments, Section 229.170) and are subject to inspection at any time during operation.

Note: Operating a temporary food establishment without an approved permit is a violation of City regulations. Legal action or closure may be imposed against such an operation.
