A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRENHAM, TEXAS CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION HELD ON MAY 1, 2021 FOR THE PURPOSE OF ELECTING ONE COUNCIL MEMBER FOR PLACE 1 – WARD 1; ONE COUNCIL MEMBER FOR PLACE 3 – WARD 3; ONE COUNCIL MEMBER FOR PLACE 5 – AT LARGE; AND ONE COUNCIL MEMBER FOR PLACE 6 – AT LARGE TO THE CITY COUNCIL OF THE CITY OF BRENHAM, TEXAS, EACH FOR A FOUR-YEAR TERM

WHEREAS, at a special meeting of the City Council of the City of Brenham, Texas, held at the regular meeting place in City Hall located at 200 West Vulcan Street, Brenham, Texas on May 4, 2021, a quorum being present, there came on to be considered the returns of the general election held on May 1, 2021 for the purpose of electing one council member for Place 1 – Ward 1; one council member for Place 3 – Ward 3; one council member for Place 5 – At Large; and one council member for Place 6 – At Large to the City Council of the City of Brenham, Texas, each for a four year term ending May 2025; and

WHEREAS, under and by virtue of the general election order duly enacted and approved by the City Council of said City on January 21, 2021, and thereafter duly published as required by law and for the time and in the manner provided by State statute and the City Charter, said general election was duly and legally held and conducted in the said City on May 1 2021;
